Abstract: The studies are the number, parametric. Software products used are: Tower 7, SAP2000 and ANSYS. The cylindrical and the prismatic (with a rectangular cross section) reinforced concrete ground water tanks are analyzed according to various theories and documents for design. Are composed and further developed procedures for seismic analysis of the facilities. Conclusions from the decisions are shown. Analysed are the so-called "basic models" as well as those obtained by shaping. Shown are: proposals for seismic analysis by the procedures, related to the application of Eurocode 8-4 (spectral curves and stability); "quasi-seismic" checks and shell opening checks. In general, for all studied models, can observe maximum values of internal forces in the horizontal direction (tension forces), as well as the heights of hydrodynamic waves. Instructions for determining the load-bearing reinforcements are also given.

The walls are thick, covered with flat roof, the bottoms are shaped with pyramidal funnels for emptying. The superstructure is supported by a frame stepping on the foundation plate. The interest presents different methods for analysis and combinations of impacts - from different states and stages of loading. The solutions are divided into 3 groups, with data from them. The pressures created from storing products are specific and way of reinforcing the bottom and walls depend on them. The main fragments of static and seismic analyzes are shown, as well as drawings of architectural and structural parts of the project. The purpose of presenting report is to prove the suitability of reinforced concrete facilities for the food industry althougt construction costs and implementation time.

The considered facility performs: metrological (in the pyramidal part), recreational (on the roof plate of the pyramidal part) and signal (from the top of the tower) functions. The results of static-dynamic analysis and the acceptance of load-bearing reinforcements are shown.

At the bottom is stored the so-called. "Emergency stock". In case of emergency operation of the water supply system, the pressure in the installation may be reduced. The interest in this facility is the additional hydrodynamic masses from the seismic action of the fluid. In addition to the impulsive and convective masses are the so-called dynamic (or masses taking into account the flexibility of the structure). Works with "transformed" (equivalent) loads from these masses. The main results for the load-bearing reinforcements and checks are presented through computer analyzes.

On the circular foundation slab steps a spatial system of external columns: 8 number on the periphery (inclined in height and reaching the lower support ring of the tank) and 4 internal vertical column (passing through the inside of the cylindrical water tank). Between the four vertical columns on each level, floor areas are constructed, which are connected by beams connecting columns on a given level and beams connecting internal columns (i.e. connections between the individual columns). The water storage tank itself is a hollow cylinder, inside which are 4 columns with constructed lower and upper round capitals. The roof of the tank is a round plate with a supporting upper ring. On the roof plate are realized openings - vent and inspection. The communication service of the water tower is designed with steel stairs. At the level below the tank there is a "Dry pump room". Are considered analysis by specialized software. It is important to note that both the resulting reinforcements bars and the stress and strain checks are satisfied. All this is a prerequisite for a conclusion, that this type of structures are not to be neglected in construction and in the modern aspect can be actually performed functions against for crisis regimes of water in settlements.
