This review has been prepared on the basis of documents received through a competition announced by VSU "Lyuben Karavelov" (SG No. 37 / 07.05.2021) and on the website of the University for the needs of the Department of Urban Planning, Theory and History of architecture "at the Faculty of Architecture. The documents submitted in the competition comply with the requirements of the Law on the Development of Academic Staff, the Law on the Development of Academic Staff and the Regulations for the Development of the Academic Staff of VSU "Lyuben Karavelov".

## 1. General presentation of the received materials

The only candidate for participation in the announced competition has submitted documents: associate professor, doctor of arts. BLAGOVESTA IVANOVA IVANOVA from VSU "Lyuben Karavelov". For participation in the competition, the candidate has announced and presented a list of a total of 45 titles, incl. 31 publications in Bulgarian and foreign scientific publications and scientific forums, 2 studies, 3 monographs, 3 books, 2 textbooks and 1 textbook. 31 articles are distributed as follows: (4 articles, referenced and indexed in world-famous databases, 10 articles on arts in specialized editions, 8 articles on synthesis in specialized editions, 1 article on pedagogy for teaching historical disciplines, such as art history and history of architecture and breaking the synthesis in specialized editions, 2 articles on museology, 2 articles on preservation of cultural heritage in specialized editions, 5 articles on architecture); 3 publications for maintaining a creative factory or participating in a collective product in the field of experience.

## · Candidate details

Associate Professor Doctor of Arts Blagovesta Ivanova Ivanova, according to diploma KV № 453032 graduated from 1978 to 1983. The Faculty of History of Moscow State University "M. V. Lomonosov", specialty" History of Art". In the appendix to the diploma KV № 453032 are indicated taken exams and credits for the specialty "History and Theory of Art". A certificate from the Ministry of Education and Science dated 02.10.2002 was presented on the grounds of Art. 10, para. 2, item 4 for a recognized higher education with an educational qualification degree "Master" in the specialty "History of Art".

• General characteristics and evaluation of the scientific production of the candidate

The candidate works in three scientific fields on problems described in them as follows: I. ART SCIENCE: transition from the Middle Ages to modern times in the countries of Southeast and Central Europe; Art of the Bulgarian Revival; New Bulgarian art; Museology and preservation of cultural heritage; Comparative research; II. HISTORY OF ARCHITECTURE: history of architecture from antiquity to the XIX century, comparative studies; synthesis with the fine arts. III. SYNTHESIS BETWEEN ARCHITECTURE AND ART: architecture and painting, preservation of cultural heritage. Analysis and research of the Bulgarian architectural complex of the Golden Horn in historical-architectural-artistic aspect, description and analysis of the peculiarities of the terrain and the historical constructions. Study of the temples in the Sofia diocese. The reviewer of the submitted works for professor emphasizes the synthesis of architecture and arts, indicated in the competition announcement. A total of 45 scientific publications were presented for the competition.

The author declared that "All submitted publications are outside the publications for the procedures for: educational and scientific degree doctor (1996), academic position associate professor (2007) and scientific degree doctor of sciences (2020)".

The works meet the requirements for academic publications.

## • Purpose of the study

"The purpose of the study is to obtain results about the nature of the temples, the peculiarities of the synthesis in them, the condition and accessibility. To achieve it, the planning schemes, constructions, tectonics, the synthesis between architecture and the fine arts, their condition and socialization were observed. (Line 13, p. 14)

• The ultimate expression of the goal - building a model of the churches

"The final expression of the goal is to build a model of the churches, as a preference for planning schemes for different historical periods with features of synthesis, condition, accessibility, ways of carrying out restorations and repairs, aesthetics of artistic results." (Line 17, p. 14)

## • Parameters in the descriptions

"The degree of description of individual buildings created for the model is different. This is related to the purposes of its design and is not subject to the strict and subsequently set out parameters in the descriptions. Observers are the main typological specialties and specialties for detailed guidance of the tectonics of the churches. "(Line 21, p. 14)

## Mural decoration

"In the mural decoration with traced stylistic specialties and the ways of depicting the architecture, in the cases when it comes to author's handwriting or authorship. From the point of view of interaction, they are considered, super-painted or lost in the murals ». (Line 25, p. 14).

#### In "MATERIAL STRUCTURING"

Three sections are included in "MATERIAL STRUCTURING". "The first section includes the monastic churches ......" The specific problems are related to the condition, accessibility, architectural, structural and artistic restoration and the new frescoes. The second section presents the settlement churches. They are systematized and described in chronological order from the Middle Ages to modern times. They are arranged in alphabetical order of the spiritual districts in the diocese. "(Line 20, p. 15)" The third section of the study is an analysis of the ways of depicting architecture in frescoes and icons. "(Line 5, p. 16)

In all three sections, the candidate conducted an in-depth study of literary sources (in detail and in kind as well), which is within the scope of the topic, including those that are "without year of publication and publishing number." (<sup>37</sup>, For the monasteries in the Diocese of Sofia, see: Dimitrov, D., Z. Ganeva, G. Stoyanova, The Sofia Monasteries, Origin, Development, Structure and Character, S., Publishing Center of the Ministry of Culture, edition of the Ministry of Culture, NINKN, SD "KIN", MIS Sofia, without year of issue and publishing number.)

#### Comparative style analysis

"Synchronous and diachronic comparative style analysis was used. Among the settlements, those of different nature have been selected on the basis of their historical development, and larger and smaller ones in terms of population must be included in them". (line 1, p. 15)

#### Chronological scope

"The chronological scope is the time from the Mature Middle Ages to the present. The description of the individual objects was made according to the data provided by the material, according to its condition at the time of the study. (line 4, p. 15).

The author's statement is justified that "In this aspect is the new contribution - to introduce into circulation an analysis of the synthesis between architecture and art, as well as the current state of the temples visited in the Sofia diocese." (line 6, p. 15)

The candidate emphasizes the synthesis of architecture and the arts, the connection of churches with the environment, the structural elements (arch and vault), and the material. The legislative documents with the names Hatisherifa1 and Hatihumayuna2, giving the rights of Christians in Turkey, are considered. Evidence for this is determined by the following texts from the monograph:

# • Synthesis between arts and architecture

"In the Divotin Monastery, in addition to the ratio of old-rebuilt new construction in a complex, the example of the old and the new is manifested in terms of the synthesis between the arts between them and their relationship with architecture. The arches and walls on both sides of the dome in the old church are painted. The iconostasis is a modern design, with royal and proscomedy doors and is placed on the site of the previous board. » (Page 35)

## • Relationship with the environment

"The monastic churches I see here are different in plasticity, form and connection with the environment. This group is indicative of the connection with the historical tradition and with the existence of a new form." (Page 39)

## • Structural elements (arch and vault)

- "The western façade is designed in the spirit of the medieval churches in the Sofia diocese with antiques flanking the entrance to the nave. They are shaped in the upper part as an arch, which on the facade expresses the construction of the arch." (Line 23, p. 41)
- Legislative documents with the names Hatisherifa<sup>1</sup> and Hatihumayuna<sup>2</sup> were used in the text. (line 8, page 44)
- The candidate professionally and competently considers the formation of the churches as an integral part of the socio-economic, religious, historical and economic events of the era.

## • Recommendations for Monograph 1

In some of the graphic images of the churches there are no plans and sections, and when there are any of them they are without exact graphic correspondence. The valuable observations, conditions, analyzes, generously and precisely presented in the text of the description of a large number of churches (in order to be accessible to the widest range of readers), need a professional glossary for specific words / expressions. When republishing, it is proposed to supplement the monograph with such a dictionary for explanation of words / phrases, such as:

The Kyustendil Sandzak; triconchos, (p. 21); the inscriptions in the proscomedy with names, (p. 26); the diaconic tympanum, (p. 31); conch in the nave, (p. 33); chrisms, (p. 34); with anti flanking the entrance to the nave (line 23, p. 41); or "... expressed by Hatisherifa1 and Hatihumayuna2, with regard to the rights of Christians in it", (line 8, p. 44); "In it, above the royal icons, a wood-carving frieze with teratological ornaments has been developed ..." (line 6, p. 57); the incarnations of Jesus Christ; (line 10, p. 58); proskinitaria, (p. 166) and others. Abbreviated names in capital letters of the institutions should be entered with their full name at the end of the monograph.

#### About the figures:

- Pages 181 and 182 are described with repetitions;
- On page 170 (Nativity of the Mother of God in the village of Radul) there are vague fragmented images, due to a strong contrast with the larger sizes of figures on the same page;
- On page 157, below, "Details of the frescoes on the nave", become "on the nave";
- On page 156 in the church "St. Paraskeva "in the village of Breze" South facade and gates of goats "should be replaced by" goats ";
- On page 154 in the church "St. Petka in Breznik, Transka spiritual district, the bell tower is missing from the plan;
- On page 153, the church "St. Nikola" in the village of Maritsa, the facade is southern and eastern due to the angle;

- On page 152, the church of St. Peter and Paul "in the village of Mala Tsarkva, the facade is western and southern, not only southern;
- On page 147, the Church "St. Petka "in Tavalichevo, the plan does not mark the places of the designations of the two sections, which are also incomplete;
- On page 145, the Church "St. Georgi" in the Kyustendil district of Kolusha, there is no complete correspondence between the plan and the three-dimensional image of the interior;
- On page 143, the Church "St. Prophet Elijah "in Boboshevo" has figures without characteristics (specific thematic description) of the images;
- On page 138, there is no image of the Holy Trinity Church in the Suhodol Monastery;
- On page 137, the name in the "Northwestern facade of the church" St. Inav Rilski "should be replaced with" St. Ivan Rilski ";
- On page 131, the church in the Zemen Monastery there are inaccuracies in the section;
- On page 130, the door from the facade is missing in the plan, as a door to enter the building;
- On page 126, the Church of "St. Archangel Michael "in the Tran Monastery there is a discrepancy between the plan and the section of the church.
- Monograph 2. Blagovesta Ivanova. "Trapko Vassilev and the PERMANENT ART GALLERY. 110 years since its inception. Paradigma Publishing House. Sofia 2020. ISBN 978-954-326-438-4. The research of the Permanent Art Gallery is related to "searching for information about its creator and its role as a center for exhibitions and a building in the center of Sofia after 1910." with reconstructions of spaces, reconstructions, etc.
- Monograph 3. Blagovesta Ivanova, Valentina Varbanova. "Thessaloniki-Sofia. Comparative study of architectural monuments in Antiquity and the Middle Ages. VSU "Lyuben Karavelov". ISBN 978-954-331-070-8.

According to a separation protocol, signed by Associate Professor V. Varbanova on June 3, 2019, Associate Professor B. Ivanova is the author of the chapter "Historical Model" with subparts 1-1.3.1. It includes pages 6-34 of the monograph. A synchronous comparative study of architectural monuments from the region of Thessaloniki and Sofia was performed. "To the main topos - Thessaloniki and Sofia are attracted on a synchronous, diachronic and territorial basis other sites to provide a set of historical situations and architectural solutions in which to look for common features and differences." (line 5, p. 6). The aim of the project is for students to acquire professional knowledge and skills in the specialty "Preservation of architectural heritage".

**Recommendations.** ..... The units of the International System of Units (SI)... "are not used in the sizes described in the text of line 2, page 20; "The still undiscovered hippodrome is the second largest in Europe (150 x 450 m)."

#### **Textbooks**

1. Ivanova, Bl. Art history for architecture students. Ciela, S., 2015, vol. 1, First Edition, Second Edition (ISBN: 978-954-28-1723-9). "The main emphasis in it is the connection between architecture and the fine arts. Comparative tables, tasks and exercises help to create skills for building structured and logical thinking in the field of historical knowledge, as well as for the development of visual memory. The first volume contains a CD with 1200 color images, chronological tables, diagrams and historical maps."

Text. Exercises and historical maps should be changed.

- A characteristic of the "Fine Arts in Ancient Egypt in Synthesis with Architecture" is given. It is achieved through painting and reliefs, which have a significant place in the design of wall panels. Egyptian art documents public life. It is of two types: elitist and non-elitist. The elitist is for the rich and expresses the supreme power of the pharaoh. (line 16, p. 36)
- The synthesis between architecture and sculpture from the 5th century BC.

"The masters of the V century BC. They successfully solve one of the most important tasks in art, which in all epochs faces architects and sculptors - the synthesis between architecture and sculpture. The statues fill the field of the pediment and harmoniously coordinate with its outlines. The dimensions of the figures on the left and right of the pediment are symmetrical in size. Architecture and sculpture complement and enrich each other. (line 22, p. 60) The greatest role in

the history of classical art of ancient Greece was played by the sculptural decoration of the temple of Zeus in Olympia from the middle of the 5th century BC ...... "A very important feature is the impact of each of the sculptures as an independent and at the same time uniting them in a group and as a whole with the architecture". (line 6, p. 61)

"The synthesis in Rome during the Republic and the Empire was achieved on the basis of the unification of architecture, sculpture and painting. Architecture creates a spatial organization for the experience environment. The environment of the forum in which the sculptures are located. They also have a place in the arched spaces of construction (the Colosseum, the basilicas, the archive). "(Line 22, p. 70)

## · "Chapter three. Art of classical antiquity

"Main features of painting in ancient Rome and the connection with architecture

The cities of Pompeii and Herculaneum have preserved the most frescoes, which create a clear idea of the development of painting in ancient Rome. "(Page 76)

"Chapter four. Art of the European Middle Ages, (Line 6, p. 103)

"The synthesis between architecture and the fine arts

"The synthesis is justified by the architectural features of the walls and the temple space. It is achieved with different types of materials. In the decoration of the external walls it is expressed in the mixed masonry by combining brick and stone, unfolding the detail and polychromy. The synthesis in the interior is complex. It is built by combining different materials (stone, paints, wood), techniques (mosaic, fresco, relief) and color. The iconographic program is one of the artistic means to achieve it. (Line 6, p. 103)

• The candidate has presented the link with the clearest examples of synthesis with a qualitative description of space

"One of the clearest examples of synthesis is the catholicon in the monastery of Hozios Lucas from the tenth century. It is dominated by the domed space. The other rooms are small, dark, with cross vaults. The mixed masonry and the relief division of the wall panel with arches is a peculiarity in the architecture of the Macedonian Renaissance. (Line 15, p. 103)

The candidate is eloquent in describing the significance of the sculpture.

"Sculpture depends on architectural forms. It can be in front of a wall or a column, to decorate capitals, imposts, often there are arches above the figures. The variety is characteristic, the dimensions depend on the Divine and social hierarchy." (line 5, bottom up, p. 114.)

The periodization of the Renaissance occupies a special place in the work. The periods, the centers, the artists and the main features of the periods are indicated. "Pre-Renaissance (Proto-Renaissance) - XII-XIII centuries (for the XIII century the term ducento is used). Florence, Siena and Milan in Northeastern Italy; Early Renaissance - XIV-XV centuries (Trecento, Quatrocento). Leading authors are Giotto, Masacho, Piero de la Francesca, Sandro Botticelli. Frescoes and altar paintings are typical. High or Mature Renaissance - from the 90s of the XV century to the first three decades of the XVI century (Cinquecento). Leading authors are Leonardo, Michelangelo, Raphael, Bramante, Palladio. The frescoes, the altar paintings and the secular portraits are typical. Late Renaissance - 1530–1580, and Mannerism from the second half of the 16th century to 1630. The two periods are not clearly distinguished, which is evident from the periodization. Leading authors are Giorgione, Titian, Veronese and Tintoretto. (line 14, p. 125) On p. 173 are given "Appendix. Test tasks and exercises "to test students' knowledge.

**Recommendations.** In Bulgaria, "According to Art. 3 and 11 of the Law on Measurements,.... are allowed to use only the units of the International System of Units (SI)... ", which are not used in the sizes described in the text:

- on line 26, page 48; "Their function is to mark the place of burial (they are about 155 cm high)"; - on line 20, p.71: "The column of Emperor Trajan is 30 m high." - "Cult and spectacular facilities and their decoration. The Altar of Peace (11.6 x 10.55 x 6 m), 13-9 BC, is a cult facility associated with the triumphant return of Emperor Octavian Augustus from Spain and Gaul. "( line 14, page 72).

2. Ivanova, Bl. Art history for architecture students. Ciela, S., 2017, vol 2. (ISBN: 978-954-28-2255-4). The second volume of art history covers the period from the Baroque in the seventeenth century to World War II. University courses in general history of art and architecture at Cambridge, Buston, Brown University in the USA and others are taken into account. "Regarding architecture, separate examples are considered in terms of style, spatial construction, form formation and their cultural context. «The second volume contains a CD with an application with 900 color images, chronological tables, diagrams and historical maps. The candidate has made analyzes and given important definitions of "Baroque aesthetics"; "Synthesis in Versailles"; "First Stage of Classicism"; Rococo; "Realism as a concept"; The Secession and others.

**Baroque aesthetics** includes important components. "The aesthetics of the baroque are characterized by the ideal and sensual beginning, the intensity of feelings, grandeur, splendor, dynamism, pathetic exaltation, spectacular spectacle, the combination of illusory and real, the contrast between scales, rhythm, combination of different materials, texture. (line 9, p. 10)

In "Chapter Seven. FRANCE IN THE SEVENTEENTH CENTURY "describes very precisely" The Synthesis in Versailles. Versailles combines architecture, landscape and fine arts into a complete complex, which embodies the greatness of the state in the face of the king and the creative power of architects who worked for several decades until the completion of its overall appearance. "(Line 17, p. 69)

# A characteristic of the First Stage of Classicism is given

"In the seventeenth century was the first stage of classicism, when the peculiarities of the style were not yet fully formed. Then the public and palace facilities, the city ensembles and the palace and park complexes were maintained in the spirit of official solemnity. Forthe spatial solutions are characterized by clear logic, the facades are calmly harmonious, the compositions are proportionate, the architectural forms are simple and strict." (line 19, p. 74)

In "The Concept and Style" (line 9, p. 76) the specifics of Rococo are revealed. "Rococo is associated with the time of the regency of Duke Philip II of Orleans (1715-1723) and spread throughout Europe under King Louis XV (1715-1774). It is distinguished by elegance, grace, decorativeness, theatricality, lightness and intimate-coquettish character. In architecture it replaces the "heavy" baroque and at the same time is a logical result of its development and its antipode. "(line 17, p. 76)

A precise comparative analysis between the main features of the Baroque and Rococo styles in the interior is presented in the table on page 82.

In "Chapter Nine. THE MULTILATERAL XIX CENTURY "is also considered Realism as a Concept. ....... It is based on the visible similarity of the image to reality, on the selection of basic, defining features of the depicted object and is related to the correct reflection of the essence. Within realism, grotesque, symbolism and allegory are possible. (line 16, p. 112).

In Chapter Eleven THE MODERN AGE "The secession in architecture is connected with new planning schemes of the buildings and with the abandonment of the order divisions. All elements of the architecture are subject to a single ornamental rhythm and are united in a common design with pronounced symbolism. (line 25, p. 152)

"Architecture is characterized by the use of new materials (concrete, glass, metal) and combining them in a new way, the formation and decoration - flowing spaces, curved or rounded outlines of cornices, doors and windows, stylized decorative details, pale refined tonality, combination of wood, metal, colored glass, frescoes, carving, relief. "(line 6, p.154)

Chapter Twelve "THE BEGINNING OF DESIGN IN THE TWENTIETH CENTURY" (p. 174) sheds light on the Verkbund. the beginning of the industrial production of furniture, fabrics and

other articles of glass, wood and metal with clear, appropriate and functionally justified forms. "(Line 19, p. 175)

On page 209, part 2 ends with "Appendix. Tasks, exercises and tests.

The current problems in the protection and the current state are analyzed, conclusions for good and bad practices are made. (B-3) The condition for the observation period 2015-2017 is registered. The aspects and the degree of the possibilities for protection in regional aspect are noted. With the mentioned examples an analysis of the accessibility is made through the prism of the obligatory requirements for marking and access to the buildings. (B-3)

• 7. The thesis

The thesis that the painted architectural elements are understood as replacing the masonry ones. Particular attention is paid to the connection dome / vault-medallions, in some places - evangelicals around the medallions as substitute structural elements - domes and pendants. (habilitation work B-3).

• 8. Contribution to the accelerated construction in Sofia after the Liberation

Contribution to the study of Lion Bridge and Eagle Bridge with archival documents for the assignment of work on the construction of foreign construction companies, in the context of urban planning and accelerated construction in Sofia after the Liberation. (G-9: 5)

## III. Synthesis between architecture and fine arts

Contribution to the study of the approaches of the painters of the Late Middle Ages and the Renaissance for the depiction of buildings, architectural elements, interiors and urban spaces in church painting; (Monograph 1)

# • 9. Constructions of types of buildings

The types of buildings that are depicted and represent basilicas and rotundas - buildings from antiquity have been studied. With regard to the constructions, they are column-beam, which have not been preserved and are painted according to patterns; (Monograph 1)

## • 10. Comparative aspect of language texts

Linguistic texts (from iconographic manuals, erminia) and frescoes in the churches in the Sofia diocese have been studied in a comparative aspect. The depiction of space, architecture and architectural elements in church painting is compared with texts from the hermines about space, architecture and architectural forms; (monograph 1)

# • 11. Features of depiction and verbal descriptions

The peculiarities of depiction and verbal descriptions of squares, residential buildings, palaces (public buildings), churches (religious buildings), structural elements - columns, stairs, domes, interiors and the views of painters on the artistic interpretations of the nature of the materials are considered. The research is based on pictorial material from the Late Middle Ages and the Renaissance. (see B-3 - habilitation work).

## • 12. Contributions to the study of the arts in the urban environment and sculpture in it

Comparative studies of the urban environment and the sculpture in it in a comparative aspect between Sofia, Skopje and Ashgabat are made, covering the topic of symbolism, historical images and approaches to the plastic suggestion of images. (G- 9:20)

# • 13. Graffiti and graffiti as frescoes

Graffiti and graffiti have been studied, and in them, as frescoes from different times, the connection with architecture, space and place, and their perception in the urban environment has been sought (G-9: 23).

# • 14. Study of 3D mapping

Exploring 3D mapping and the possibility of changing the facades of buildings by turning objects, often irregularly shaped, into a video projection surface; (G-9: 21). The visual side - the interaction between architecture and 3D mapping has been studied.)

#### • 15. The comparative study of murals

Contributions to the comparative study of frescoes in churches, mosques and Revival residential buildings in terms of the architectural elements, decorative solutions and landscapes used in them. (G-9: 19).

#### • 16. Contributions to the study of Bulgarian architectural heritage abroad

The Bulgarian architectural complex of the Golden Horn in the Republic of Turkey has been studied; (Articles G-8: 1, 2; G-9: 6, 9, 10, 12, 14, 17, 18, 22, 23, 27). Interdisciplinary research has been carried out in a team - the contribution consists in uniting the work of different specialists (G-8: 1, 12). The unbuilt building of the Bulgarian Exarchate (G-9: 25) and the work of Bulgarian artists in Istanbul (G-9: 4) are studied separately.

An incredible desire to "touch" the objects is the main goal for their detailed study and research. The candidate demonstrates high literary awareness. The formulated contributions and obtained results are his personal merit. The candidate offers a concrete, concise and convincing interpretation of the synthesis of architecture and arts, revealed on the basis of the studies of the churches in the habilitation work "Monastery and settlement temples in the Sofia diocese", unpublished publications for the "Bulgarian architectural complex of the Golden Horn", textbooks 1 and 2 part, etc. Declarations for lack of co-authorship are attached to them.

- Monograph 1. Monastic and settlement temples in the Sofia diocese. monitoring, condition, analysis, accessibility 2015 2017. Regarding the figures:
- The lack of situational plans does not allow to establish the exact location of the churches in the environment and their interaction with it. In some of the figures of the churches no plan, cross and longitudinal sections are presented. In some examples, there is no complete correspondence between the architectural plan and the sections.
