I. Analysis of the problems of existing structures

Short description of the chapter

In this chapter are discussed:

- 1. Topicality of the problem
- 2. Analysis of the existing building stock in Bulgaria
- 3. Defects and damages in existing structures
- 4. Reliability of building structures

Some conclusions are made.

1. Topicality of the problem

Currently, towns and villages are built with a very diverse building stock - both new and older buildings of different materials. The density of construction is increasing, especially in the central parts of large cities. The lack of vacant land for new buildings necessitates the adaptation of existing ones to a new function.

The problem of restoring and strengthening existing structures is very relevant. The need for proper interventions on Europe's aging building stock will become increasingly apparent.

2. Analysis of the existing building stock in Bulgaria

The existing building stock of Bulgaria consists of buildings and facilities with various constructions: masonry, reinforced concrete (prefabricated or monolithic), steel, wooden (braided) and mixed (braided construction with brick filling, combined steel-reinforced concrete construction, steel-wooden elements etc.).

The dissertation describes the percentage share of each structure for the number of dwellings and the number of buildings.

Conclusion: As an analysis of the data it can be done that in Bulgaria there is a significant number of masonry structures (with wooden or reinforced concrete floor structures), followed by reinforced concrete, and other types of structures are less common. Focusing on the problems of these buildings is essential for the future development of Bulgarian towns and villages.

3. Defects and damages in existing structures

In order for a strengthened structure to be properly modeled, the strengthening structure must be properly modeled. First, it is necessary for the analysis of the existing structure and secondly it is an important step in the modeling of the reinforced structure.

The dissertation lists the most important defects and damages and we will make the necessary comments related to the real behaviour of the structure and its modeling. Examples will be shown, some of which are from the author's practice as a designer.

- 3.1. Defects and damages in reinforced concrete structures
- 3.2. Defects and damages in masonry structures, as well as in masonry, which work as part of the load-bearing structure for horizontal factions of buildings with reinforced concrete skeleton
 - 3.3. Defects and damages in steel structures
 - 3.4. Defects and damages in wooden structures

Conclusion: The modeling of structures with defects and damages is a complex problem that does not always have an accurate and practically achievable solution. Proper (as far as possible) modeling is very important for the right design decision for such structures.

4Reliability of building structures

The concept of "reliability" of building structures is briefly discussed and some examples of amortization of structures are presented.

As a conclusion, for example for brick buildings with wooden floor constructions, it can be said that the replacement of wooden floor constructions with new ones is a good option, as the intervention on the load-bearing brick elements may be less due to their lower amortization over time. .

II. Analysis of the historical development of the regulation in the design of building structures and the existing regulations in the field of restoration and strengthening

Short description of the chapter

Some conclusions are made about the development of the actions on the buildings along the time the constructions are calculated, some conclusions and recommendations are done in the estimation of existing buildings.

1. Historical development of the regulations in Bulgaria related to actions on buildings and structures other than seismic action

The breaf review of the history of design standards is useful for the proper assessment of buildings and facilities.

Since the creation of design standards, design statements have changed significantly, and most loads have increased. The first regulations in Bulgaria were Rules for construction of private buildings in the cities of the Bulgarian principality [Правила за строеж на частни здания в градовете на българското княжество] and were established in 1881. With the advent of reinforced concrete as a more widely used material the Regulations for the design of reinforced concrete structures in the Kingdom of Bulgaria were invented. [Правилник за проектиране на стоманобетонните строежи в Царство България].

It should be borne in mind that the older standards work with the admissible stress method with a common safety factor, usually is in the admissible stress of the material. This leads to a certain unpredictability regarding their conservatism compared to the current regulations.

The effects related to the weight of structural elements are determined on the basis of densities, ie. they should not change according to the regulations. Live and climatic actions (snow, wind) are regulated.

The first regulations in Bulgaria are rather informative - wall thicknesses are described and so on. Subsequently, the norms began to impose more calculations, specific physical models of describing the phenomena were imposed.

Conclusion: In conclusion, it can be said that all buildings, designed according to regulations after 1935, if they are designed, built and maintained properly, are designed to have sufficient and even commensurate with the current regulations reliability for vertical actions, with some exceptions for climatic effects.

Practice will prove the reduction of load-bearing capacity of structures over the years.

2. Historical development of the regulations in Bulgaria related to antiseismic design of structures

An interesting conclusion made in [Ignatiev, N., .P. Sotirov, History of the Bulgarian norms for seismic survey of structures and transition to a structural system Eurocodes, presentation, http://www.petkovstudio.com/documents/7.pdf] and [Providing buildings for seismic impacts, KIIP, Engineering Forum, no. 6, 2012] shows that buildings built between 1964 and 1987 should be considered seismically secured, as in most cases the seismic forces in the 1964 Regulations are greater than the seismic forces in the 1987 Regulations. In § 1. item 4 of the additional provisions of Regulation № RD-02-20-2 of 27 January 2012 on the design of buildings and facilities in earthquake areas] it is written that "Unsecured buildings" are the buildings that are built before 1987. "

3. Regulations relating to the retrofitting or strengthening of buildings

3.1. Historical development of regulations related to the inspection, evaluation or reinforcement of buildings

Evaluation, restoration and strengthening of buildings are problems that have always been outside or have been slightly affected by the regulatory framework.

In 42 point of the 1987 Earthquake Design of Buildings and Facilities states that "Unsecured and seismically protected buildings may be rebuilt and upgraded [...] if it is proved that after redevelopment and upgrading the same are seismically secured in accordance with the requirements of these norms". This requires that in any reconstruction the building or facility be insured against an earthquake, according to this regulations.

Simultaneously with this document was widely used [Project Association Association Guide 1988]. This guide gives some mitigating requirements and although it is not a normative document it has been used frequently in the past [Traikova, M., Restoration and strengthening of buildings. Problems, constructive solutions, practical examples ISBN 978-954-9897-40-1].

3.2. Bulgarian regulations

In the current regulations in Bulgaria, the problem of evaluation, restoration and strengthening of buildings is addressed in only a few articles. [Regulation RD 02-20-19] and [Ordinance № RD-02-20-2 of 27 January 2012 on the design of buildings and facilities in earthquake areas] provide the main points in the assessment of buildings and facilities and the need for reinforcement. The main idea is that the structures are checked for compliance with the regulations under which they are designed, and if they meet, a positive assessment is given. In case of change, it is not necessary to meet the requirements of the current regulations if the masses do not increase by more than 5%, if there are non-design drilling of openings, which

reduce the bearing capacity and ductility up to 5% and there are defects and damages, displacements of reinforcement and others, which reduce the bearing capacity up to 5%. If the mass increases by more than 5% or there are more serious interventions in the structure, it must be strengthened in accordance with current regulations. Exceptions are immovable cultural values, for which deviations are allowed, although it is not said which ones. The dimensioning of the structure, in case it needs to comply with the current regulations is done according to national standards or Eurocodes depending on the assignment of the contracting authority (for sites 3-6 category, according to the The low for the regulation of the territory) or mandatory Eurocodes for sites 1-2 category or some public procurement. Reconstruction requires technical inspection, compliance with the requirements for maximum allowable height and number of storeys, seismic assessment and investment project.

Some authors [Georgiev, A., V. Penchev, Seismic resistance of buildings designed before March 1, 1987, Stroitel newspaper, 2012] believe that the statement should give a positive assessment of buildings that do not comply with current regulations. system is incorrect. There is logic in this, but in the author's opinion it is not possible to strengthen the buildings, according to the current regulations, because this would require global intervention in any case, and local would lose all meaning. This would unduly burden the country's economy.

In the author's opinion, a positive assessment should be given to buildings designed and implemented according to the norms in force at the time of their design, but also to meet some minimum requirements for seismic safety, for example to be designed for reduced seismicity compared to at the time of assessment current seismic norms. This is a kind of environment that will not require every single structure to be reinforced, but it will not allow buildings and facilities that are totally unsecured from seismic impacts to receive a positive assessment.3.3. БДС EN 1998-3

Eurocode 8 [БДС EN 1998-3] is specifically dedicated to the seismic assessment of existing buildings. Unfortunately, again, recommendations for non-seismic security are completely missing.

IV. Admissible stresses and strains in FRP strips

Short description of the chapter

In this chapter are discussed:

- 1. Admissible stresses and strains in the FRP strips. Theoretical statement

Conclusions are in relation to which standard is closest to the experimental results in the world and their conservatism.

1. Admissible stresses and strains in the FRP strips. Theoretical statement

The material from which the strengthening strips are made is very strong, and the most likely form of destruction is debonding of the FRP strips.

Debonding usually occurs by breaking by cutting the base (brick wall, concrete) on which the FRP strip is glued, not in the adhesive layer, because it is stronger, nor on the border of the adhesive layer with FRP strip or base, because the adhesion is big enough. Shear stresses are distributed according to a strongly curvilinear law along the length of the FRP strip and after a certain distance, representing the anchoring length, are very small.




Fig. 56. Diagram of the distribution of tangential stresses with a glued strip of FRP [Francesca Ceroni, Barbara Ferracuti, Marisa Pecce, Marco Savoia, Assessment of a bond strength model for FRP reinforcement externally bonded over masonry blocks, Composites Part B: Engineering, Volume 61, 2014, Pages 147-161, ISSN 1359-8368, https://doi.org/10.1016/j.compositesb.2014.01.028.]

After processing these expressions, assuming the bilinear approximation of the shear stress diagram to s_{ult}, the formulas in the CNR-DT 200 standard for determining the allowable stresses and strains in the FRP bands given in Chapter 3 are made.

2. Admissible force in FRP strip according to the regulations

2.1. Admissible force in the FRP strip according to CNR-DT 200

From the substitution of formulas given in Chapter 3, and taking into account the fact that the calculated maximum force in the amplifier band is $F_{cnr-dt, d} = f_{fdd}.b_f.t_f$, we obtain the following formula:

2.2. Admissible force in the FRP strip according to CNR-DR 200 / R1

From the substitution of formulas given in Chapter 3, and taking into account the fact that the calculated maximum force in the amplifier band is $F_{cnr-dt-R1, d} = f_{fdd}.b_f.t_f$, we obtain the following formula:

Comment and comparison between CNR-DT 200 and CNR-DT 200 / R1


The admissible forces received under the CNR-DT 200 / R1 edition are significantly higher than those received under the original version of the standard, due to several significant differences:

First, the version of the standard uses the average, and in the original version the characteristic value (5% fractil) of the compressive strength of the wall. Given that the strength of a wall is a random variable with a large scatter of the average value (unlike that of steel, for example), this will lead to serious differences.

Second, the coefficient c_1 when determining the specific energy of destruction is replaced by k_c . This coefficient for a brick wall is 0.031, which is more than twice the value of $c_1 = 0.015$.

Third, a coefficient kb has been added. Let us examine the values of this coefficient from the case when the width of the FRP band is equal to the width of the strengthened element (such a case is almost impossible in practice) to values about 1/5 of the ratio of the effective width of

the FRP band to the width of the strengthened element (5cm strip on a brick wall 25cm, for example).

It can be seen that it is greater than 1, and for the common cases in practice there are values 1,2-1,4.

2.3. Determination of allowable force in FRP bands using the ACI 440.7R-10 methodology

This standard uses a much simpler methodology based on empirical dependencies. Permissible deformations of the reinforcing strip are given with different formulas depending on whether bending or shear damping is being investigated. Since bending fracture results in a clearer and purer stress state, much like that realized in the experiments to determine the force of detachment, this method will be used here to calculate the allowable force in the reinforcing strip.

If the failure is due to shear, there is a different and more complicated methodology for calculating the allowable stresses. The difference is in replacement of the coefficient km with kv, as kv has values from 0.2 to 0.4 depending on the physico-mechanical coefficient of reinforcement with FRP.

The permissible characteristic force in the FRP band, taking into account that $F_{aci, k} = \epsilon_{fe}.E_f.b_f.t_f$, is:

According to this formula, a force can be calculated that can be compared with the experimental one.

3. Experimental results and their comparison with the theoretical

The dissertation presents experimental results from various literature sources around the world. Calculations were made and experimental and theoretical results were compared.

In the absence of data calculations, a deformation deformation of 1.7% was assumed, which is typical for most carbon FRP bands.

Test results in which the destruction is not debonding but another type, such as brick destruction, are not included as not indicative of the allowable strength in the FRP strip. In experiments where the experiment is two-sided, the shear forces for one strip are given, i. half of those experimentally measured.

For greater clarity, a calculated and characteristic value of the force of failure according to CNR-DT 200 is given.

Based on the comparative analysis of experimental and theoretical results, the following Conclusions can be made:

The results obtained in the first edition of the CNR-DT 200 are very conservative and differ significantly from the experiments.

The results obtained in the second edition of the CNR-DT 200 / R1 are closer to the truth and in almost all cases in favor of security. As they often turn out to be quite conservative, it would be economically advantageous to use the "design by testing" approach at larger sites to reduce the amount of reinforcement input.

The American standards ACI440.7R-10 give the closest to the experimental results, although the computational setup is incomparably simpler and takes into account much less input data. The problem is that often the results obtained are not in favor of security.

As a Conclusion, it can be said that the CNR-DT 200 / R1 turned out to be the most detailed and with the most reliable results.

5. Anchoring length

The dissertation describes some features and made some models related to the length of voltage transmission. Of course, on a model this length is less than the calculated one, because the real construction has imperfections.

In conclusion, it can be concluded that the modulus of elasticity of the adhesive layer affects the length of stress transmission, although this is not reported in any of the regulations.

V. Determination of stiffness in the plane of a FRP strengthened masonry wall

Short description of the chapter

In this chapter are discussed:

- 1. Description of the problem
- 2. Determination of the reduced center of gravity of a strengthened wall with a certain length of the compression zone
- 3. Determination of the reduced moment of inertia of the strengthened wall
- 4. Coefficient of modification of stiffness in software product

In order to be able to properly model a wall strengthened by FRP strips, its rigidity must be known. This chapter derives formulas for modifying stiffness in a software product, provided that the wall is strengthened with evenly spaced strips of FRP.

1. Description of the problem

The problem of the stiffness of a masonry wall in its plane, reinforced with vertical and horizontal stripes of FRP is one of the tasks we set ourselves. This stiffness serves to more accurately determine the self-oscillation periods (although it is difficult to speak of good accuracy in masonry structures), to determine the horizontal displacements of the building and so on.

The task is complex due to several factors:

- the participation of masonry is excluded from work in a tension zone
- the participation of vertical FRP strips is excluded from work in the pressure zone

A description of a similar problem with reinforced concrete sections (meaning the exclusion of concrete in the tensile zone, not reinforcement) is in [Ivanchev, I. Design of reinforced concrete bridges according to Eurocode 2. ISBN 954-8873-97-3]

If the problem of switching off the masonry during tensile operation is similar to that of reinforced concrete elements, then switching off the FRP pressure strips is a specific problem. Its difficulty comes down to the fact that a general formula should cover first how many of these strips will "work" at a given pressure zone height and secondly their contribution should be covered in a formula convenient for computer analysis (if possible to avoid cycles for easier integration into Microsoft Excel, for example).

We will look at a wall strengthened by vertical strips of FRP at equal distances, the strips facing each other. Longitudinal compression deformations due to in the time of application of FRP

are considered to be negligibly small. We believe that the horizontal strips of FRP are dimensioned to ensure shear forces destruction.

Schematically, the problem is presented in the figure:




Fig. 50. Indications for the stiffness in the plane of a wall problem

VI. Dimensioning the strengthening with FRP. Procedure. Conclusions

One of the most convenient ways to design in compression and bending moment of masonry walls strengthened with vertical strips of FRP is to use an interactional diagram. Formulas have been developed by which such a diagram can be drawn, the wall is strengthened by evenly distributed strips of FRP. A table has been created in Microsoft Excel environment for practical application.

1. General statements

Standards [CNR DT 200/2004] and [ACI440.7R-10 Guide for the Design and Construction of Externally Bonded Fiber-Reinforced Polymer Systems for Strengthening Unreinforced Masonry Structures] set out general guidelines for dimensioning reinforced masonry walls with FRP materials in and out of their plane. The aim of this chapter of the dissertation is to develop a procedure for dimensioning masonry walls strengthened by FRP. This finds various applications in real practice, for example in the case of seismic reinforcement of masonry structures, it is important to determine the load-bearing capacity in the plane of the brick wall, acting as a shear wall.

Some basic statements are given in [Benedetti, Andrea & Steli, Elisa. (2008). Analytical models for shear–displacement curves of unreinforced and FRP reinforced masonry panels. Construction and Building Materials - CONSTR BUILD MATER. 22. 175-185. 10.1016/j.conbuildmat.2006.09.005.].

2. Load-bearing capacity of a wall, strengthened with FRP materials in its plane. Interactional diagram

The main principles for testing the load-bearing capacity of a wall strengthened with vertical strips of FRP for bending moment and normal force are given in Chapter 3.

One of the ways to study eccentrically compressed and eccentrically tensioned elements, which has gained popularity recently and illustrates the load-bearing capacity of the section, especially if it needs to be tested for several pairs of torque and normal force, is the interactional diagram.

The peculiarities of constructing an interaction diagram of a masonry wall strengthened by FRP materials, compared to a reinforced concrete wall, are the following

- FRP fabric has a perfectly linear-elastic stress-strain relationship, unlike reinforcement, which has a yielding horizontal part
- the procedure must be such as to calculate the admissible deformations in FRP, because they depend on the type of fibers and the characteristics of the reinforced wall
- the procedure must be such that it takes into account when the FRP strip is pressed
 at each iteration to determine the number of stretched and pressed strips and to exclude from work the pressed
- to determine the number of strips itself, ie to be able to work on any wall with a set distance between the strips
- since the FRP strips are not placed as the reinforcement in zero stress state, the procedure must take into account the stresses in the wall during the installation of FRP the wall will be pressed at least with a vertical load. Usually these stresses can be assumed to be evenly distributed
- An additional feature is the determination of the allowable effort when no strip has "worked", ie. the cross section is eccentrically pressed with the result in the core this problem is not related to the problem of reinforcement with FRP, but is important for determining the load-bearing capacity of the existing wall and the need for reinforcement in another way

Procedure for drawing an interactional diagram for a reinforced concrete wall is given in [Milev, J, V. Kardzhiev, Design of reinforced concrete structures according to Eurocode 8, ISBN 987-954-92274-3-11], guidelines for drawing an interactional diagram of material which does not allow tension are given in [Simple Method for the Design of Jet Grouted Umbrellas in Tunneling, Gian Piero Lignola, Gaetano Manfredi, Journal of Geotechnical and Geoenvironmental Engineering 134(12):1778-1790 · December 2008]

Based on these guidelines, a procedure for drawing an interactional diagram on a masonry wall strengthened with FRP materials will be shown.

Let's first look at an interactional diagram of a masonry wall that is not loaded with initial stresses during application of FRP strips, for example a wall on the top floor of a building with a dismantled roof or with a negligibly small load from it. We will work with the statements given in [CNR DT 200/2004 / R1].

Let's consider the case where FRPs are located at equal distances, they are the same (which is the most common case in practice), their number is arbitrary (set by the distance between them) and the wall has a rectangular cross section in plan (no contribution of the transverse wall is taken into account).

L - length of the wall

b - width of the wall

f_{mb} - average value of compressive strength of masonry

FC - coefficient of safety of masonry, determined depending on the type of masonry, according to Eurocode 6 [BDS EN 1996]

Type of fibers used for reinforcement: carbon fibers, aramid fibers, glass fibers

System type: certified system (application type A), non-certified system (application type B)

tf - nominal thickness of one FRP layer

E_f - modulus of elasticity of FRP

w is the width of the FRP strips

s - axial distance between FRP strips

a - distance from the tensioned end of the wall to the axis of the first vertical strip of FRP

 ε_{fk} - admissible deformations in case of FRP rupture

l_b - Anchoring length: at least the required or below the required size




Fig. 51. Indications

For the purposes of the dissertation, a table in Microsoft Excel environment has been developed, which works according to the given formulas.

If it is necessary to take into account the initial deformations in the masonry when gluing FRP, proceed as follows. Again, the same distance values set for the compression zone x are used, which are fictitious values here. The real values are obtained from the fictitious ones by the following considerations.

The permissible deformations in FRP do not depend on the initial stresses, so reaching the limit state due to tensile deformations will be at the same value. But the picture of compressive stresses will be different, because there will be areas where we will have both tensile stresses in FRP and compressive stresses in the wall. A view of the stress and strain state is given in the following figures.




Fig. 52. Stresses and strains in a wall strengthened by FRP strips at initial compressive stresses in the wall, less than the allowable tensile stresses in FRP




Fig. 53. Stresses and strains in a wall strengthened by FRP strips at initial compressive stresses in the wall, grater than the allowable tensile stresses in FRP




Fig. 54. Table in Microsoft Excel environment

A computer program on the Lazarus platform has been created, which draws an interactional diagram and determines the height of the compression zone at a given normal force (bending moment is the maximum corresponding to it) for any wall (with widenings at the ends contributing to the compression zone) located strips of FRP (Algorithm itself works up to 6 strips, but the principle would be the same for more).

1. General provisions

The algorithm outlined in the previous chapter is very useful, but only works on a wall with a rectangular cross section (no cross walls) and evenly spaced reinforcing strips. Therefore, in this chapter we will show algorithm and its application in the Pascal programming language environment, Lazarus platform. With the help of this program, users will be able to draw an interaction diagram of a brick wall reinforced with up to 6 FRP vertical stripes (the use of more would be rare in real practice), located randomly and with different numbers of FRP strips in each strip, as and take into account the presence of transverse walls at one or both ends of the wall. It is assumed that the deformations in the wall during the bonding of FRP are small and are neglected by the subsequent redistribution of forces.

The width of the strip of transverse wall, which acts as a contributing width, is determined in accordance with the requirements of Eurocode 8 or another relevant standard by which the structure is dimensioned. In the program it is set this cooperating width by the user.

2. Program overview and input

All input and output data must be located in the program window - in this case the graph. Buttons are needed to draw the interaction diagram and to clear the diagram to make a new one in case it does not need to be compared with the previous one.




Fig. 55. View of the program with numbering of the objects for input data




Fig. 56. View of the program – output




Fig. 57. Vie of the program - output




Fig. 58. View of the program - output




Fig. 59. View of the program - output




Fig.60. Anchoring in reinforced concrete element in epoxy-filled groove, shown in 'ACI




Fig.61. Anchoring with anchoring facilities




Fig.62. Anchoring proposal




Fig.63. SAP model




Fig.64. Bending moments




Fig..65. Normal forces

The proposed anchoring option is applicable when the foundation protrudes away from the wall (if this is not the case, the FRP strip can easily be applicated directly to the foundation). The idea is to change the direction of the FRP strip with the help of a cold-bent profile, appropriately attached to the strip foundation, and to subject it to decoupling by cutting with the foundation. Peeling of the stretch strip to the surface of the foundation is prevented by the metal profile. The profile is cold-bent to have a rounded edge, not an edge to cut the FRP strip.

IX. Conclusion

We can make the following conclusions:

- The modeling of existing structures and their strengthening is a complex task.
 Detailed inspection of defects and damages is necessary in view of proper analysis and engineering interventions.
- Regulations are currently poorly developed in the field of evaluation and reinforcement of existing structures and therefore the role of the designer in the survey and proper interventions in the building is greater than in the design of new buildings.
- Buildings with load-bearing masonry are the most common in Bulgaria. It is possible to strengthen them with FRP stripes.
- The most common form of destruction of the strengthening system is debonding of
 the strips from the base. World standards in this area are few and provide different
 methods for determining the admissible stresses and strains. CNR-DT200-2004 /
 R1 is the most suitable for use, and for larger sites it may be cost-effective to design
 by testing because the results of this standard are conservative.
- The stiffness in the plane of a wall reinforced with FRP strips is less than that of a crack-free wall and depends on the size of the compression zone. In the dissertation algorithm is proposed to determine this stiffness.
- The dimensioning of the strengthening system is a complex task, which generally requires a cyclic Algorithm for iterations. If there are transverse walls, they should be taken into account (according to the requirements of the normative documents), because they seriously affect the interactional diagram. The dissertation proposes two algorithms, an Excel spreadsheet and a computer program to solve this problem.
- An important condition for the good operation of the reinforcing system is the correct anchoring in the foundations. In the dissertation a new variant solution is proposed.

Claims for scientific and applied contributions:

- 1. An overview and critical analysis of the problems of interference in existing structures in connection with:
 - Defects and damages and their modeling
 - Legislation
- 2. An overview of the theories and regulations for admissible deformations and stresses in FRP strips externally applicated to walls has been made. They are compared with a wide range

of experiments around the world and recommendations are made to the designers for the conservatism of each of the normative documents..

- 3. A formula is derived and a table is created in Microsoft Excel environment for determining the stiffness in the plane of a masonry wall, strengthened with uniformly distributed and equidistant vertical strips of FRP.
- 4. An algorithm and a chart with diagrams in Microsoft Excel environment have been created for drawing an interactional diagram on a masonry wall, strengthened with identical, equidistant strips of FRP.
- 5. Algorithm and a computer program (.exe file) were created to draw an interactional M-N diagram and to determine the height of the compression zone at a given normal force (bending moment is the maximum corresponding to it) on any wall with widenings assisting in the pressure zone and random and randomly located strips of FRP.
- 6. A new variant detail of the connection to the foundations of a vertical strip of FRP on a wall is proposed.
